Dear Business Owner,

It's time for The Tenth Annual Wedding Show, presented by the Gunnison-Crested Butte Wedding Council. The Wedding Show will take place on Sunday, January 15th, 2012 from 2-5pm at the Grand Ballroom in the Lodge at Mountaineer Square.

The Wedding Show is a wonderful opportunity to showcase your business to many current and prospective brides looking for wedding professionals in the Crested Butte area, and it's also a great chance to network with others in the wedding industry.

Weddings impact almost all businesses in the community. Even if you don't work directly with brides, you are sure to be affected by weddings in the area, and the Wedding Show will allow you to connect one on one with them. If your target audience is brides and weddings in the Gunnison - Crested Butte area, then this is an event not to be missed!

Important Notes:

- Wedding Council Members receive a significant discount on their booth fee. The average cost of a Wedding Council Membership is \$100.00. If you are not already a member, sign up now! It will benefit you to become a member and pay the lower booth fee for the Wedding Show.
- Once you register for the show, you may choose your booth location on a FIRST COME, FIRST SERVE basis. The booth map is located at Misty Mountain Too in Clark's Plaza. You may drop your registration and payment at Misty Mountain Too or send it by mail to P.O. Box 146, Crested Butte, CO 81224.
- All booths requiring electricity must be on the perimeter of the ballroom - NO EXCEPTIONS. Extension cords will not be permitted to run across the aisles.
- Vendors are permitted to serve food and beverage at their booth but NO ALCOHOL is permitted unless you are a CBMR business. This is a violation of CBMR's liquor license. CBMR is generous in donating space, tables and lodging package for the Show, please respect this rule.
- Vendors will need to provide their own linen and table displays
- Vendors are welcome to include marketing materials in the goody bags to be passed out to all attendees. Please have enough materials for 50 bags to Misty Mountain Too in Clark's Plaza no later than January 7th if you wish to be included.

Exhibitors at the Wedding Show receive:

- Exhibit Table & 2 Chairs
- Lunch for one vendor (additional lunches are \$5.00 and can be added on the registration form)
- Database of all Wedding Show attendees

If you are not able to exhibit, but would still like to be represented, you can reserve space at the brochure table and have your business information inserted into the goody bag passed out to each show attendee.

You can receive additional exposure for your business by donating a prize for the show raffle. Raffle prizes, and the businesses that donated them, are announced and promoted throughout the show.
